

Under the powers vested in me by section 35(2) of the Northern Cape Nature Conservation Act 9 of 2009, I hereby determine from the year 2013 -

- the species of fish whereon the Proclamation is applicable as listed in columns one and two of **Schedule 1b**;
- the angling seasons, the daily bag limits, minimum weight in grams and minimum length in millimeters as set out in the third, fourth, fifth, sixth and seventh columns, respectively, of **Schedule 1b** hereto,
- any special instructions as set out in column eight, of Schedule 1b;

This proclamation comes into effect on the 1<sup>st</sup> day of January 2013 **and remains valid until such time that it is re-evaluated, amended and proclaimed again.**

HUNTING SEASONS, DAILY BAG LIMITS AND HUNTING BY PROHIBITED HUNTING METHODS & INSTRUMENTS

Under the powers vested in me by section 6(2) of the Northern Cape Nature Conservation Act 9 of 2009, I hereby determine from the year 2013 -

- the species of wild animals whereon the Proclamation is applicable as listed in columns one and two of **Schedule 1**;
- the hunting seasons, areas and the daily bag limits as set out in the third, fourth and fifth columns, respectively, of **Schedule 1** hereto,
- and applicable to the activity of hunting, the extent of the suspension of sections 9 in terms of section 9(4), as specified in **Schedule 2** and column six of **Schedule 1**.

This proclamation comes into effect on the 1<sup>st</sup> day of January 2013 and remains valid until such time that it is re-evaluated, amended and proclaimed again.

**EXPLANATORY ADDENDUM (SCHEDULE 2)**

Column 6 of the Hunting Proclamation indicates the extent to which section 9 (prohibited hunting methods) in terms of section 9(4), is suspended. When the relevant paragraph of section 9 is suspended in the Hunting Proclamation in respect of a specified species, it means that specific prohibited hunting methods may be used to hunt that species. A short explanation of each paragraph mentioned in the Hunting Proclamation is furnished hereunder:

**Section 9 (Prohibited hunting methods) in terms of section 9(4) of the Northern Cape Nature Conservation Act 9 of 2009.**

- (b) by means of poison;
- (c) by means of a vehicle or aircraft;
- (d) during the night;
- (e) with the aid of an artificial light, floodlight or spotlight;
- (g) by means of a trap cage;
- (h) by means of a gin-trap;
- (k) by means of a firearm which discharges a rim-fire cartridge of a 5.56 mm (.22 inch) caliber or smaller caliber;
- (l) by means of a firearm which discharges more than two shots without being manually reloaded;
- (o) by means of a set gun, poison-firing apparatus or any similar device;
- (p) by means of darting or a device which injects an intoxicating or a narcotic agent or poison into such animal;
- (q) which is kept in captivity, confined to a cage, in an enclosure or trapped against a fence where it does not have a fair chance of evading the hunter;
- (r) which is under the influence of a tranquilising or narcotic immobilising or similar agent;
- (s) by the use of a dog
- (v) by luring or by means of a simulation or recording of the natural sound made by an animal or by means of bait or scent or any other induced luring method;

- (o) deur middel van 'n stelgeweer, gifskiet-apparaat of enige soortgelyke toestel;
