AAN: LIDVERENIGINGS

Aangeheg vir u **dringende aandag** is die jongste Vuurwapen Regulasies soos gewysig 2007 wat in die Staatskoerant **no.30401** gedateer **26 Oktober 2007** afgekondig is.

CHASA se Raad het onder die leiding van Neil Jones 'n Taakspan aangewys om die regulasies te bestudeer en kommentaar daarop voor te berei wat aan lidverenigings gesirkuleer sal word, alvorens dit aan die Dir. Bothma, Hoof van die SVR voorgelê sal word. Volgens die Regulasies sal daar ook 'n konsultasie proses volg sodra al die kommentare ontvang is. Lidverenigings word uitgenooi om hul insette **direk** aan Neil Jones te stuur by e-pos neil@tech-unlimited.co.za. Indien lidverenigings verkies om ook individuele kommentaar te lewer, is hulle meer as welkom om dit te doen – 'n Afskrif van sodanige kommentaar moet egter ook aan die kantoor deurgestuur word. Neem die vrymoedigheid om aan te dui wat nie in die regulasies opgeneem is nie asook op die inhoud daarvan. Volgens die Staatsdrukker is daar nie gedrukte voorraad van die Regulasies beskikbaar nie en is dit tans slegs elektronies beskikbaar. CHASA sal egter die Owerhede daarop attent maak indien die gedrukte en elektroniese weergawe sou verskil.

Let asseblief op die **D-datums** wat die proses sal volg:

1. Lidverenigings kry geleentheid om hul kommentare **direk** aan Neil Jones te stuur. Datum: 16 Nov. 2007
2. Neil en sy Taakspan **formuleer** kommentaar. Datum: 23 Nov. 2007
3. Konsep dokument van Taakspan word aan lidverenigings **gesirkuleer** vir kommentaar/insette. Datum: 26 Nov. 2007
4. Lidverenigings **reageer** op konsepdokument. Datum: 30 Nov. 2007

FIREARM REGULATIONS

12 November 2007

TO: MEMBER ASSOCIATIONS

Attached for your **urgent attention** is the Firearm Control Amendment Regulations 2007 which have been promulgated in Government Gazette Notice, **no. 30401** dated **26 October 2007**.

The Board of CHASA has appointed a Task Team to be headed by Neil Jones to study and formulate comments which will be circulated to member associations, before submitting it to Dir. Bothma, Head of the CFR. According to the Regulations a consultation process will follow after all the comments have been received. Member Associations are invited to submit their comments **directly** to Neil at email neil@tech-unlimited.co.za. Should member associations prefer to comment individually, they are most welcome to do so - A copy of such comment should however also be forwarded to the office. Feel free to comment on what you feel is not in the amendments but should be, as well as what is in there. According to the Government Printer there is no stock available of the printed Regulations. It is only available in electronic format. CHASA will, however, inform the authorities should there be any discrepancies between the printed and electronic versions.

Kindly take note of the **D-dates** the process will follow:

1. Member Associations are afforded the opportunity to submit their comments **directly** to Neil Jones. Date: 16 Nov. 2007
2. Neil and his Task Team to **formulate** comments. Date: 23 Nov. 2007
3. Draft document of Task Team **to be circulated** to member associations for comments/inputs. Date: 26 Nov. 2007
4. Member Associations **to react** on draft document. Date: 30 Nov. 2007
